## Terms and conditions of service

- 1 Service fees are charged upon a 42 day positive test and must be paid fully within 30 days of issue of invoice.
- 2 A live foal guarantee applies on all services on the condition that service fees are paid in full within 30 days of receipt invoice for service fee. If the mare slips the foetus, the foal is stillborn, or the foal dies within 24 hours of birth, the mare has a free service the next season or the service fee may be refunded less 20%. A claim for a dead foal must be accompanied by a veterinarian's certificate made no later than 24 hours after the death of the foal.
- 3 Discounts are given for two or more mares.
- 4 Interest of 18% per annum will be charged monthly to overdue accounts.
- 5 All agistment, worming, vaccination and vet costs are the responsibility of the mare owner. These fees must be paid before the mare leaves the stud.
- 6 Agistment rates are upon application and will vary according to the needs of each mare and climatic conditions.
- 7 A foaling fee will be charged on all mares foaling at the stud to cover nightwatchman's expenses and standard post-foaling treatments for mare and foal.
- 8 All mares should be vaccinated for strangles and tetanus before arriving at the stud, or the studmaster notified if not. It is stud policy to vaccinate pregnant mares for strangles, tetanus and salmonella four to six weeks prior to foaling for the protection of the newly-born foal.
- 9 Our stud employs a full-time vet. A one-off breeding fee per mare will be charged to cover vet costs pertaining to reproduction of the mare including pre-breeding and ultrasound scanning for follicle and pregnancy testing. Extraordinary treatments drugs and veterinary supplies will be invoiced separately.
- 10 A one-off working fee will be charged to mares on the stud bred to outside stallions via semen transport. This fee **does not** apply to off-farm mares bred to our stallions.
- 11 Frozen semen will be charged at a flat rate upon application. This includes vet breeding fee and working fee. Any extraordinary treatments, illness or injury will be invoiced separately. Frozen semen will not be used where chilled semen is available.
- 12 Egmont Park Stud reserves the right to reject any mare not in good condition physically, or not clean and fit for breeding.
- 13 The studmaster should be notified of any problems with the mare's breeding history, and also if the mare is insured.
- 14 All stallions are registered with the QHRB for service by artificial insemination.
- 15 Egmont Park Stud will take all reasonable care of mares and foals, and reserves the right to employ veterinary care to ensure the full well-being of mares and foals at owner's cost. Neither Egmont Park Stud nor its members, agent and employees shall be liable for injury or death or disability suffered by a mare or its foal, from any cause whatsoever whilst in the care of Egmont Park Stud. The mare owner specifically agrees to such conditions and waives each and every claim for damages resulting from such injury, death or disability. Insurance of valuable mares is recommended.
- 16 A mare cannot be served unless her registration papers (or a copy of them) are in the hands of the studmaster and all correct ownership details are recorded on them. A copy of registration papers for mares requiring transported semen must be in the hands of Egmont Park Stud **prior** to transportation of semen.
- 17 Semen will only be sent to registered AI accredited stud farms or a registered veterinary practice that has been approved by the appropriate state harness racing board or authority.
- 18 All costs associated with transporting semen will be met by the mare owner. A credit of \$50 will be given for each equitainer returned to Egmont Park Stud.
- 19 All costs at destination of semen, including scanning, insemination, other vet fees, agistment and stud working or handling fees etc, will be met by mare owner.
- 20 Cancellation of bookings. If for any reason at all a booking is to be cancelled, please notify the stud as soon as possible.
- 21 **Mares will not be served without completion of booking form.** This also applies to permanently agisted mares.
- 22 All prices are inclusive of GST.
- 23 By signing the front of this booking form you are accepting these terms and conditions. Please retain the yellow copy for your records.
